**EAA 327 Officer's and Director's Meeting  
Locust Street HyVee, Oct. 8, 2009**

Meeting was called to order by president Larry Mueller at 6:47 pm with 8 members present.

**REPORTS:**

- Secretary: Mike Gaffney read minutes from previous meeting held Sept. 3rd and they were approved with the corrected time of Christmas cocktail hours at 6:00 pm and party to follow at 7:00 pm.
- Treasurer: Dennis Schares reported a balance of \$8,726.84 but with some breakfast related checks still to be written.
- Membership/Retention: Lyle Hefel nothing to report.
- Advertising/Promotion: Harry Styer gave an extensive report of meeting with Karen and airport people. Harry reported that the airport was happy with the response from the public and wanted to repeat the open house next year, but had concerns about the slow moving breakfast line.

**OLD BUSINESS:**

- + Breakfast and airport discussion continued and centered on the check paid by Paul Kaune new owner of David Flying Service. It was thought that given the fact that we are having the breakfast in his hangar, we should tear up the check. John Einck motioned and Dennis Schares 2nd to approve destruction of the check and next year reserving a block of 30 tickets for Paul's use—passed.
- + Dennis Schares raised question of making our annual donation to the CAP for their car parking help. Larry Mueller noted that we also donate to UD flight team as well. By consensus it was voted to approve both donations and payment will be made in November.
- + Harry Styer continued his report from the airport meeting and the airport group offered a number of ways to speed up the serving line. They suggested adding another pancake machine and getting more tables and even having us serve an extra hour. There was concern that there was no one to help handicapped individuals carry their trays. The airport folks said they were disappointed with local radio coverage and that they noticed that some people were leaving w/o being served. Karen and the airport group said that next year they will probably have fewer hours of open house. Larry Mueller reported that total open house estimates ran as high as 4 to 5 thousand people.
- + Concerning next year, Dennis Schares cautioned that this year may have been unique and poor weather conditions could bring numbers down next time around.
- + John Einck praised UD for their support and said we must be generous when they ask for help with their breakfast. John also said that we should be prepared to order for more food for next year's event.
- + Harry Styer reported that he was shopping for best prices for replacement tables and that Menard's wanted \$75 for an 8 footer with discount price of \$68. Harry motioned and Lyle Hefel 2nd to purchase 10 new tables when we get best deal—passed.
- + Larry Mueller spoke of upcoming elections in November.
- + Larry also reported that the Christmas party will be held at Catfish Charley's and Larry will be telephoning members with a reminder as the time nears.

**NEW BUSINESS:**

- + Mike Gaffney reported that there will be a speaker at the November meeting. Larry suggested that having food might also bring more
