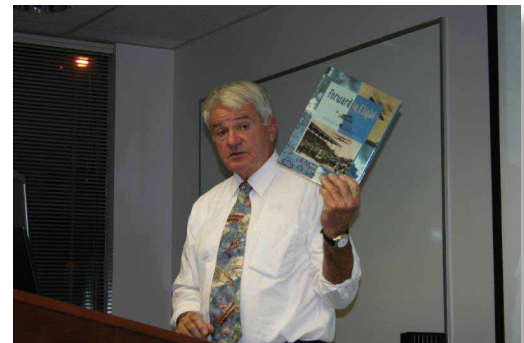


Minutes
